The OECD/Korea Policy Centre will host, in collaboration with the International Labour Office (ILO) and the Asian Development Bank (ADB), a social experts' meeting on the 19 and 20 of November 2008, in Seoul, Korea. We are very pleased to invite you to participate in this event. A draft agenda for the meeting is attached to this letter.

The aim of the meeting is two-fold. First, we will review a draft report "Society at a Glance (SaG): ASIA Edition" prepared by the OECD/Korea Policy Centre, which reviews Social Indicators in Asia, and we will discuss the outcomes. This publication (which will be sent to you in advance of the meeting) offers a concise but comprehensive, quantitative overview of social trends and policy developments in Asian countries, modeled upon "Society at A Glance – OECD Social Indicators".

Second, we will review improvements in social protection statistics in Asian countries, share country experiences, and discuss future plans for joint ADB/ILO/OECD data collection on social expenditure, financing and recipients. This work follows up to three important international work on social protection statistics: i) the ADB Social Protection Index, which was discussed at last year conference; ii) the ILO Social Security Inquiry, which collects national data and scheme-level administrative data on social security around the world; and iii) the OECD Social Expenditure database (SOCX), which monitors trends in social expenditure at the aggregate and changes in the composition of social expenditures.
